1. Bids are hereby invited for the Supply, Delivery, Installation, Testing and Commissioning of Radio Communication Equipment for Department of Fisheries and Aquatic Resources, Colombo 10.
2. Bidders shall propose and provide all relevant equipment/resources or any other item required to run the proposed Equipment if the available equipment/resources mentioned the specification of DFAR is inadequate. The proposed Equipment shall be a fully functional equipment/resources offered shall be proven products.
3. The work shall include following:
 - 3.1. Installation of the proposed Radio Communication Equipment at the customer indicated locations without any burden to the customer.
 - 3.2. Testing and Commissioning of the Equipment shall be carried out by the supplier after installation at customer location.
 - 3.3. Local training shall be provided for the staff of the customer by the supplier, free of charge, at installation locations.
 - 3.4. The solution shall have a warranty as specified in clause 19 “Warranty & After Sale Support”, under Specific Conditions of Bid.
4. Project Milestones
The Supply, Delivery, installation, testing and commissioning and any other activity of proposed Equipment shall be completed within Three (03) months from the date of LC.

The Contractor shall provide advanced proven products that do not require any further research and development, and are in current production and in service in a number of other locations.

INSTRUCTIONS TO BIDDERS

1. **Definitions**

- 1.1. **Bid** means a formal offer indicating the price for the scope of work, compliance with specifications and other terms to execute all Work related to the Supply, Delivery, Installation, Testing and Commissioning of Radio Communication Equipment.
- 1.2. **Bidder** means party who submits a formal offer to execute all Work related to the Supply, Delivery, Installation, Testing and Commissioning of Radio Communication Equipment.
- 1.3. **Buyer** means Department of Fisheries and Aquatic Resources (DFAR) who is inviting offers from prospective Bidders to execute all Work related to the Supply, Delivery, Installation, Testing and Commissioning of Radio Communication Equipment.
- 1.4. **Contract** means formal agreement between selected Bidder and Buyer to execute all Work related to the Supply, Delivery, Installation, Testing and Commissioning of Radio Communication Equipment.
- 1.5. **Successful Bidder** means, the Bidder who's Bid has been accepted to execute all Work related to the Supply, Delivery, Installation, Testing and Commissioning of Radio Communication Equipment.
- 1.6. **Employer/Company** means Department of Fisheries and Aquatic Resources. (DFAR)
- 1.7. **Contractor** means the successful bidder who's bid has been accepted and entered into contract with the Employer.
- 1.8. **Goods** mean commodities, raw materials, products, equipment, tools, software, documents and other physical objects of every description, which are necessary to execute the Contract.
- 1.9. **Life Time** means the minimum operational period of offered Radio Communication Equipment during which the Bidder guarantees to provide the 'support' to maintain the system operational as specified and agreed by the Contact agreement.

- 1.10. **Services** means delivery of goods to Site, safeguard of equipment from the delivery to the site until Site Acceptance Test (SAT), installation, auditing, testing at site, training at site and on-site assistance to be provided by the Bidder under this Contract.
- 1.11. **Technical Specifications** means the document, where the features and characteristics of the Radio Communication Equipment and Services being the subject matter of this Contract are described.
- 1.12. **Work** means all activities, including supply of Goods & Services, associated with the Supply, Delivery, Installation, Testing and Commissioning of the Radio Communication Equipment.

2. **Bidding Document**

- 2.1. 3. **Closing of Bid / Bid Opening**

- 3.1. Bids will be closed at **2.00 PM on 30th July 2024** at the Department procurement committee, Department of Fisheries and Aquatic Resources, 3rd Floor, New Secretariat Building, Colombo 10. and will opened immediately thereafter.
- 3.2. Any Bid received after the closing time will be rejected unopened. Postal or other delays will not be considered as valid reasons for acceptance of late bids.
- 3.3. Bidders or their duly authorized representatives shall be present at the time of opening of Bids. The names of Bidders as well as the price quoted will be read out at the opening of Bids.

4. **Qualification, Eligibility and requirement of the bidder**

- 4.1. Principal/Manufacturer of the equipment may also apply and the details of the local representative should be declared. Such Company or institution should have been registered in their respective country and such authorization/registration letters should be forwarded with the bidding documents.
- 4.2. If the bidder is the local agent of the Principal/Manufacturer of the equipment, bidder shall be a firm registered in Sri Lanka under the Business Names Registration Ordinance or incorporated under the companies Act, No. 7 of 2007.
- 4.3. This invitation for Bids is open to accredited agents of Radio Communication Equipment those who have valid Vender license issued by the Telecommunication Regulatory Commission of Sri Lanka.
- 4.4. Bidder should have minimum 05 years of experience in the Business of Radio Communication equipment within Sri Lanka and should provide minimum 03 years of records of such experiences during the past 7 years with evidence.
- 4.5. Bidder must have appropriate workshop facilities for Radio Communication equipment in Sri Lanka to minimize downtime. Details of technical staff should also be provided.

5. **Personnel or firms comes under the following categories will not be considered for the award of the contract**

- 5.1. Who are in the Company/State Defaulting Contractors' List
- 5.2. Who had/is having unresolved disputes with the DFAR
- 5.3. Who are in arrears in any payment owing to the DFAR

- 5.4. Who are in breach of any obligation towards the DFAR including default as a surety
- 5.5. Who have failed to perform diligently any previous contract with the DFAR

6. **Amendment to Bidding Documents**

At any time prior to the deadline given for submission of bids, the Procurement Committee may amend the Bidding Document by issuing an Addendum. The amendment shall form an integral part of the bidding documents. The bidders should acknowledge the receipt of the amendments.

7. **Preparation of Bids**

Language of Bids

The language of the bids should be English and any correspondence between the Bidder and the DFAR or vice versa shall be in English.

8. **Bid Guarantee**

Bids not accompanied by a Bid Guarantee will be rejected. Please refer Clause 03 of “General Conditions of Bid” for details.

9. **Notifications of Acceptance**

- 9.1. Notice of acceptance of the Bid will be sent to the selected Bidder by “Registered Post” in the form of a “Letter of Award” to the address given on the Bid.
- 9.2. If there is a change in Bidders address, bidder shall forthwith notify the “Accountant (Supplies), 3rd Floor, Department of Fisheries & Aquatic Resources, New Secretariat Building, Maligawatta, Colombo 10”. Email to dfaracpro@gmail.com.

10. **Evaluation of Bids**

All Bids will be evaluated and compared on the following criteria.

- 10.1. Compliance with the Instructions / Specific Instructions / General Conditions of Bid / Specific Conditions of Bid.
- 10.2. Conformity with the Specifications.
- 10.3. Proof of Ability.
- 10.4. Manufacturers Guarantee / Warranty offered.
- 10.5. Standards.

- 10.6. Prices.
- 10.7. For evaluation, exchange rate at the BID opening date will be considered.

11. **As per the Public Contracts Act No. 03 of 1987,**

- 11.1. No Bid, if submitted by an agent, sub-agent, representative or nominee for or on behalf of a Bidder shall be accepted for the purpose of evaluation unless the said agent, sub-agent, representative or nominee produces at the time of submission of the Bid, a Certificate issued under Section 11 (1) of the Public Contracts Act No. 03 of 1987.
- 11.2. Every Bidder who has himself submitted a Bid and who has been shortlisted for consideration of award, shall being so shortlisted produce a Certificate issued under Section 11 (1) of the Public Contracts Act No. 03 of 1987 prior to award. No Bidder to whom this Condition applies shall be eligible for award of the Contract unless he has complied with the terms hereof.
- 11.3. Regardless of whether the Bid was submitted by the Bidder himself or by an agent, sub-agent, nominee or representative for or on behalf of a Bidder, the person that submitted the successful Bid shall register the ensuing Contract with the Registrar of Companies.

1. Specific Documents to be submitted with the Bid

- 1.1. Documents to prove conformity to Technical Specification of the offered Radio Communication Equipment as per Specifications.
- 1.2. Certification by the Bidder that all hardware and software proposed for the solution will work to meet the expected performance. The contractor is responsible to solve if such issues arises during the project.
- 1.3. Details of recent installations as per General Conditions of Bid.
- 1.4. List of technical personnel to be involved in the contract as per General Conditions of Bid.
- 1.5. List of Hardware Equipment.
- 1.6. Schedule for On-site Operational and Technical training as per "Specific Conditions of Bid".
- 1.7. If the Bidder is not the Principal/Manufacturer, Audited financial statements of the immediate past three (03) years and Bank Statements for the immediate past three (03) months of the bidder.
- 1.8. If the Bidder is not the Principal/Manufacturer, Bidder shall have the authorization from the Principal/Manufacturer to supply the relevant Equipment in Sri Lanka and shall furnish Documentary evidence in this regard.
- 1.9. If the Bidder is not the Principal/Manufacturer, Bidder shall submit a recommendation letter from the Principal/Manufacturer stating the ability of the bidder to successful implementation of the proposed solution.
- 1.10. A List containing information on all installations of the proposed product/model with contact details shall be provided.

- 1.11. Principal/Manufacturer shall provide a written assurance stating that spare parts for all the equipment are available for a period of ten (10) years at the Principal/Manufacture and they are willing to sell spare parts directly to the DFAR
- 1.12. Valid Vender license issued by the Telecommunication Regulatory Commission of Sri Lanka.

GENERAL CONDITIONS OF BID

1. **General**

- 1.1. Bidders shall acquaint themselves fully with General & Specific Instructions, General & Specific Conditions of Bid and the Specifications. No plea of lack of information or insufficient information will be entertained at any time.
- 1.2. The Bids and any Contract resulting there from shall be governed by and construed according to Laws of Sri Lanka.
- 1.3. No Bid shall be considered unless all the conditions laid down in the document have been strictly fulfilled.

2. **Power of Procurement Committee to Accept or Reject Bids**

The Department Procurement Committee reserves the right to reject any or all Bids or any portion of the Bid without adducing any reason. The Procurement Committee may accept any or all items of the Bid and reserves the right to increase or decrease the quantity offered at the rates quoted. The Procurement Committee further reserves the right to annul the procurement process in whole in the best interest of the DFAR without adducing any reason. The Bidder should be prepared to accept and execute a portion or any item of the Bid at the rate quoted in the Bid Form against each item.

3. **Bid Guarantee**

- 3.1. Each Bid shall be accompanied by an on demand Bid Guarantee in the form of a Bank Guarantee issued by a Bank approved by the Central Bank and operating in Sri Lanka and payable to Director General, Department of Fisheries and Aquatic Resources, equivalent in value of Sri Lankan Rupees Three Hundred Thousand (Rs 300,000.00) and USD 1000. Failure to submit the Bid Guarantee at the time or before the closing of Bid will result in the Bid being rejected.
- 3.2. The Bid Guarantee shall be valid for One Hundred and five (105) days from the 'date of closing of Bid. Bid Guarantees from Unsuccessful Bidders will be returned to them after an award is made to the selected Bidder. The Bid Guarantee of the selected Bidder will be returned after receipt of the Performance Guarantee.
- 3.3. Specimen Bid Guarantee is shown in the section titled "Specimen Form of Bid Guarantee".

4. **Performance Guarantee**

- 4.1. The selected Bidder shall furnish an on demand Performance Guarantee within fourteen (14) working days of receipt of the Letter of Award in the form of a Bank Guarantee, from a Bank approved by the Central Bank and operating in Sri Lanka. Such Guarantee shall be equivalent to ten percent (10%) of the Contract Price and valid for a period of not less than four (04) months from the date of LC.
- 4.2. The Performance Guarantee shall be in favour of Director General, Department of Fisheries and Aquatic Resources.
- 4.3. In the event of default on the part of the Bidder resulting from breach of agreement or relevant conditions hereto, the Director General, DFAR may, by written notice terminate the Contract and collect the Performance Guarantee without recourse to law.
- 4.4. Specimen Performance Guarantee is shown in the section titled "Specimen Form of Performance Guarantee".

5. **Minimum Validity Period of Bids**

- 5.1. Bids shall be valid and open for acceptance for a period of ninety one (91) days from the date of Closing of Bid / Bid Opening.
- 5.2. All prices shall be firm and shall not be subjected to any price variation within the validity period of the Bid.
- 5.3. Bids shall not be withdrawn after the Bid opening and during the period of validity of the Bids.

6. **Bid Price Variations**

Unless otherwise specifically provided, no adjustments of the Bid Price shall be made on account of variations on the costs of labour and materials or any other matter affecting the cost to the Bidder in fulfilling his obligations under the Contract.

7. **Proof of Ability**

- 7.1. The proposed solution/product and any third party addition shall be in the business in the industry for more than ten (10) years.
- 7.2. If the Bidder is not the Principal/Manufacturer, the annual turnover of the Bidder in the last 3 years shall be Sri Lankan Rupees 150 Mn or Equivalent in USD/EURO or more.
- 7.3. Firms, Companies or Institutions registered outside Sri Lanka may also apply and the details of their local representative should be declared if any. Such Company or Institution should have been registered in their respective country.
- 7.4. The proposed Radio Communication Equipment of the bidder stated in the bid document should be related to the Bidder's Registered Business.

8. **Manufacturer's Products Specifications / Brochures**

Bidders shall furnish along with the Bid the Original Product Specifications / Brochures published by the manufacturer of the Equipment.

Any items that have been necessitated to be specified / submitted along with the bid will be subjected to clarifications/ further negotiations before awarding the contract.

9. **Completion Period**

- 9.1. Supply, Delivery, installation, testing and commissioning of the Radio Communication Equipment shall be completed within three (03) months from the date of LC. Implementation time schedule shall be submitted with the offer.
- 9.2. As and when required, the working hours under the Contract shall be adjusted to meet the targeted completion date, since access to the installation site may be restricted.

10. **Completion Within Agreed Period**

- 10.1. Extensions will not be granted under normal conditions. However, under exceptional conditions if the Contractor anticipates that the Contractor will be unable to Supply, Delivery, Install, Test and Commission the Radio Communication Equipment within the time specified in above (09.1.), Contractor shall at once give notice accordingly with justifiable reasons, in writing to the Director General, DFAR explaining the cause of the delay.
- 10.2. If an extension is requested and granted, the Contractor Shall Supply, Delivery, Install, Test and Commission the Radio Communication Equipment within the extended period. On failure to do so within such extended period, the Director General, DFAR will have the right of terminating the Contract and to encash /enforce the terms of the Performance Guarantee without prejudice to any other claims that may be lodged in this regard.
- 10.3. If the Contractor fails to Supply, Delivery, Install, Test and Commission the Radio Communication Equipment within the time prescribed in the Bid, Contractor shall be liable to pay the DFAR, one percent (1%) of the total contract price per week of delay, subject to a maximum of ten percent (10%) of the total Contract sum.

11. **Termination of the Contract**

The Director General, Department of Fisheries and Aquatic Resources shall without prejudice to any other remedy for breach of Contract, by written notice of default sent to the Contractor, terminate the Contract in whole or part thereof,

If the Contractor fails to make completion within the time specified or any extension thereof granted by the Director General, Department of Fisheries and Aquatic Resources,

OR

If the Contractor fails to perform any other obligation(s) under the Contract

AND

If the Contractor in either of the above circumstances, does not satisfactorily respond within a period of ten (10) calendar days after receipt of the notice of default from the Director General, Department of Fisheries and Aquatic Resources specifying the nature of the default(s). The contractor shall not be entitled to any compensation or damages for losses incurred upon such termination or loss of profit.

12. **Assigning and Subletting of Contract**

- 12.1. The Contractor shall not assign or sublet the works, or any part thereof, his/her obligations to Supply, Delivery, Install & Commission the Equipment offered and accepted, without the written authority of Department of Fisheries and Aquatic Resources.
- 12.2. If any part of the obligation has been so assigned or sublet by the Contractor, he/she shall nevertheless be held responsible for the due performance of the part so assigned or sublet.

13. **Patent Right Claims**

The Contractor shall indemnify and defend at his/her own cost Department of Fisheries and Aquatic Resources, against any and all claims arising on account of patent rights or royalties whether from Manufacturers or others on the use by Department of Fisheries and Aquatic Resources of the goods supplied. Further, the Contractor shall agree to honour, pay and discharge any judgment or decree arising there from.

14. **Dispute Resolution and Governing Law**
